



RESOLUTION NO. 39408

1 A RESOLUTION setting April 12, 2016, as the date for a public hearing on the
2 recommendations of the Community and Economic Development
3 Department for the 2016-2017 Annual Action Plan for Housing and
Community Development.

4 WHEREAS the Annual Action Plan to the U.S. Department of Housing and
5 Urban Development (“HUD”) will ensure the City will receive federal funds to
6 manage its housing, community and economic development, neighborhood
7 improvement, homeless assistance and social service programs, and
8

9 WHEREAS the Annual Action Plan outlined the City’s uses of Community
10 Development Block Grant (“CDBG”), HOME Investment Partnership (“HOME”),
11 and Emergency Solutions Grant (“ESG”) funds, and
12

13 WHEREAS, based on guidance by the U.S. Department of Housing and
14 Urban Development (“HUD”), the City anticipates that it will be entitled to apply to
15 HUD for entitlement grant allocations as follows: (1) CDBG, in the amount of
16 \$2,247,997; (2) HOME, in the amount of \$992,730; and (3) ESG, in the amount
17 of \$201,163, and

19 WHEREAS, because the City of Lakewood (“Lakewood”) does not qualify
20 to apply for HOME funds independently, the City and Lakewood formed a
21 consortium in 1999 for the HOME Program, and
22

23 WHEREAS the City’s share of the estimated HOME program grant funds
24 is expected to be \$805,104, and Lakewood’s share is \$187,626, and

26 WHEREAS, during January and February 2016, the Tacoma Community
Redevelopment Authority and Human Services Commission reviewed applications

for funding, heard presentations by agencies applying for funding, considered the historic performance of those agencies and the needs of the community, and prepared funding recommendations based thereon, and

WHEREAS funding recommendations were finalized at the March 15, 2016, special meeting of the Community Vitality and Safety Committee, and were recommended for consideration by the City Council at its meeting of May 3, 2016, and

WHEREAS, before submission of the Annual Action Plan to HUD, the City must fulfill certain citizen participation requirements, including holding a public hearing on the proposed plan, and

WHEREAS the draft Annual Action Plan will be available for public review for a period of 30 days, beginning on April 1, 2016, and ending on April 30, 2016; Now, Therefore,

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF TACOMA:

Section 1. That Tuesday, April 12, 2016, at approximately 5:30 p.m., is hereby fixed as the time, and the City Council Chambers on the First Floor of the Tacoma Municipal Building, 747 Market Street, Tacoma, Washington, as the place when and where a public hearing shall be held on the recommendations of the Community and Economic Development Department for the City's proposed 2016-2017 Annual Action Plan for Housing and Community Development.
