> At approximately 4:37 p.m., Susan Haigh, Acting City Clerk, informed the Committee they would be interviewing six applicants for the Commission on Immigrant and Refugee Affairs; that there are eight positions available, including six member positions, one young adult position, and one alternate position, however, the Council Members may only recommend up to six applicants as no applications were received for the young adult position; and that Maricres Valdez Castro, Negar "Natalie" Ghayoumi, Alma Villegas, and Lydia Zepeda are seeking reappointment.
