

# City of Tacoma City Council Study Session Minutes

#### Call to Order

Mayor Strickland called the study session to order at 12:05 p.m.

#### **Briefing Items**

1. <u>15-0502</u> Historic Preservation Program Annual Update

At approximately 12:05 p.m., Reuben McKnight, Historic Preservation Officer, provided opening remarks, and introduced Lauren Hoogkamer, Historic Preservation Coordinator. Ms. Hoogkamer provided an update on the Historic Preservation Program including a progress report, activities completed over the past year, accomplishments, and next steps.

Council Member Lonergan arrived here, at 12:07 p.m.

Ms. Hoogkamer continued to review upcoming events, including Historic Preservation Month activities, and a 2015-2016 calendar of events. Mr. McKnight presented a short film entitled "The Eyes of the Totem". Mr. McKnight continued with a review of restoration projects, nominations to the historic register, project review activity, review and permitting processes, upcoming briefs and recommendations, and fostering partnerships. Discussion ensued regarding the Historic Rehabilitation Repair Loan Program, the premiere of "The Eyes of the Totem", length of the film, outreach, and "Galloping Gertie".

2. 15-0503 Council Consideration Request - Heritage Organization Funding

At approximately 12:35 p.m., Council Member Walker introduced a Council Consideration Request requesting \$50,000 from the Council Contingency Fund to create a program managed by the Historic Preservation Office, which would

award funding to programs and projects that educate the public on Tacoma's rich history and heritage. Discussion ensued regarding support for the Council Consideration Request, breakdown of funds, biennium reserves, budget and future funding, level of interest, grants, program utilization, impact, allotment of dollars, and economic development.

There were no other items of interest.

### **Committee Reports**

Council Member Ibsen that the Joint Municipal Action Committee met last Friday for a Chief Executive Officer (CEO) update.

Deputy Mayor Boe stated Forevergreen Trails will meet this Wednesday, and Puget Sound Regional Council Transportation Policy Board will meet this Thursday.

Mayor Strickland stated there is a new CEO at Pierce Transit, and at Sound Transit long time leader Joni Earl will be retiring next year, and a national search will be conducted to fill her position.

Council Member Campbell stated today's Economic Development Committee meeting has been postponed.
