

**AMENDMENT NO. 1 TO  
AGREEMENT FOR LEGAL SERVICES**

**KEATING, BUCKLIN AND McCORMACK**

**THIS AMENDMENT NO. 1 TO AGREEMENT**, made and entered into effective the 8th day of October (Effective Date), by and between the CITY OF TACOMA, a municipal corporation, hereinafter referred to as the "City," and the Law Offices of KEATING, BUCKLIN AND McCORMACK, INC., P.S., hereinafter referred to as the "Law Firm."

WHEREAS the City retained the Law Firm to provide legal representation in the matter of The Geo Group, Inc., v. City of Tacoma, U.S. District Court, Western District of Washington, Case No. 3:18-cv-05233, and

WHEREAS the parties hereto wish to amend the original Agreement by increasing the contract by \$50,000, for a new maximum compensation amount of \$250,000, to allow the Law Firm to complete its work in this matter;

NOW, THEREFORE, the parties hereby amend said Agreement as follows:

1. Paragraph 2 of the Original Agreement is hereby amended as follows:

**2. Fees.**

The City shall pay the Law Firm as sole compensation for the Legal Services performed under this Agreement, such sums of money as are arrived at by computing the actual number of hours expended in the performance of this Agreement and multiplying such total hours by the hourly rates set forth in the attached Exhibit "A"; provided that, after 2018, such rates are subject to change as mutually agreed by the parties. While Michael C. Walter will be the primary attorney handling this matter, Brian Augenthaler of the Law Firm may be assigned to work on this matter, and from time to time, the Law Firm, with the City's consent, may assign other attorneys to work on this matter. Expenses for copying will be billed at an amount no more than \$0.15 per page. Other expenses will be billed at cost. Approved expert/consultant fees will be billed at the expert's rate. Other expenses will be billed at cost. The maximum

compensation associated with this agreement shall not exceed \$250,000 without further prior written authorization by City.

2. All other terms and conditions of the original Agreement remain the same.
