



ORDINANCE NO. 29036

1 AN ORDINANCE relating to the Capital Budget; amending the Capital Budget of
2 the City for fiscal years 2025-2026 for recommended budget adjustments
and Council-approved capital projects with outstanding balances.

3 WHEREAS on December 10, 2024, the City Council passed Ordinance
4 No. 29003, adopting the 2025-2026 Capital Budget, and

5 WHEREAS this ordinance will amend the Capital Budget for the following
6 reasons: (1) transfers to the Capital Budget for City Council-approved capital
7 projects and new funding; and (2) other recommended technical adjustments that
8 include costs that were not anticipated at the time the 2025-2026 Capital Budget
9 Ordinance was adopted, and

10 WHEREAS this ordinance will increase the 2025-2026 Capital Budget by
11 \$36 million, which is funded by grants, existing fund balances, and transfers mainly
12 from the General Fund, Fund 1050 Transportation Revenues, and Fund 3210 Real
13 Estate Excise Tax Fund, and

14 WHEREAS this ordinance is necessary to ensure the execution of capital
15 project commitments and will not negatively impact financial reserves; Now,
16 Therefore,

17 BE IT ORDAINED BY THE CITY OF TACOMA:

18 That the Capital Budget for the City for the fiscal years 2025-2026 is hereby
19 amended by adopting the proposed modifications as set forth in Exhibit "A," which
20 provides the detail of adjustments to the budgeted amounts in each capital fund
21 and Exhibit "B," which provides the detail of adjustments to the budgeted amounts
22 on a project-by-project basis within each capital fund, which exhibits are attached



1 hereto and incorporated herein as part of this ordinance; and that the Capital
2 Budget for fiscal years 2025-2026 shall be deemed to be and is hereby amended
3 for the recommended budget adjustments, and transfers to the Capital Budget for
4 City Council-approved projects.
