REPORTS BY THE CITY MANAGER

Assistant City Manager Tansy Hayward announced spring celebration events at Tacoma's senior centers, noting on Thursday, April 17, 2014, the Spring Bunny will visit the Lighthouse Senior Center at 5016 A Street at 10:00 a.m., followed by a visit to the Beacon Senior Center at 415 South 13th Street around 11:00 a.m. She stated this would be a chance for people who have not visited the City's senior centers to do so, noting the senior centers provide lunch for individuals over 50, Monday through Friday, and have a variety of volunteer opportunities.

She then announced the Washington Chapter of the American Public Works Association is holding its spring conference of over 350 public works professionals from all over the state at the Greater Tacoma Convention and Trade Center right now.

Ms. Hayward concluded her report by congratulating Tacoma Police Officer Shelby Boyd, who was voted as the Best Police Officer in Tacoma Weekly's Best of Tacoma 2014. She stated Officer Boyd joined the Tacoma Police Department in 2006 and is currently assigned as a Community Liasion Officer in the fourth sector.

COMMENTS AND COMMITTEE REPORTS OF THE CITY COUNCIL

Neighborhoods and Housing Committee

Council Member Walker stated the Neighborhoods and Housing Committee has met three times since the last report, and at those meetings the Committee heard a presentation on the permit process for temporary homeless camps hosted by religious organizations; reviewed funding recommendations for the City's proposed 2014-2015 Annual Action Plan for housing and community development; received updates on the City's Rapid Removal Graffiti Pilot Program and the 2014 Code Compliance windshield survey; and interviewed applicants for the Tacoma Community Redevelopment Authority Board. She stated the next meeting is May 5, 2014 and the topic is housing and foreclosure trends.

Council Member Thoms reminded all that Walk Tacoma 2014 continues its series of guided walks Wednesday afternoon with a museum walk, meeting at the Children's Museum at 15th and Pacific Avenue for a walk followed by a social afterward at Anthem Coffee and Tea.

Council Member Ibsen reported that he spoke to several hundred youth at the fifth annual Jobfest Job Fair at Metro Parks' STAR Center. He also mentioned the City's Summer Jobs 253 program.

Council Member Boe stated May is Bike Month in Tacoma and those interested can assemble a team for the commuter challenge. He announced a bike swap at the University of Puget Sound on May 3, 2014. He stated a calendar of events can be found at bike253.com, or those interested could follow or join bike conversations on social media with #Bike253. He also noted this Saturday, Tacoma Concert Bank presents "See the USA" at the Pantages Theater.

Council Member Campbell congratulated Mayor Strickland on being voted Politician of the Year in the Tacoma Weekly's Best of 2014 awards. He also thanked the Mayor and others for joining the ribbon cutting ceremony in the Lincoln District for the new Hong Kong Super Market. He noted it is just one of the many ongoing remodeling projects in the Lincoln District.
