2024 Annual Action Plan for Housing and Urban Development Grant Programs [Felicia Medlen, Housing Division Manager, Community and Economic Development]

At approximately 4:44 p.m., Felicia Medlen, Housing Division Manager, Community and Economic Development (CED), provided a presentation on the 2024 Annual Action Plan, including 2024 grant allocations; Community Development Block Grants (CDBG) in support of housing, economic development, and public services, noting programs managed by CED and Neighborhood and Community Services (NCS); Emergency Solutions Grants (ESG) allocation, and programs managed by NCS HOME Investment Partnerships Program allocations, noting funding for City of Tacoma and City of Lakewood housing programs; and next steps.

Discussion ensued regarding finalizing funding levels, process deadlines, direct negotiations with public, programs, considerations of inflation for funds; and how Lakewood and Tacoma work together for CDBG funding.

Community's Police Advisory Committee Update and Annual Report [Ted Richardson, Strategic Initiatives Coordinator, Office of Strategy]

At approximately 5:02 p.m., Ted Richardson, Strategic Initiatives Coordinator, Office of Strategy, provided a presentation on the Community's Police Advisory Committee (CPAC) 2024 review and update including an agenda; overview; 2023 accomplishments, noting an oversight recommendation, Lexipol policy review and published policies, and community outreach; 2024 goals and focus areas; and upcoming possible changes to the Committee, noting Mayor Woodards will become the Committee Liaison.

Discussion ensued regarding appreciation for CPAC members; youth position requirements and suggestions; funds; 2021 policing policies; public records request concerns; the request to shift to an oversight committee in 2024-2025; process of charging fees to CPAC; suggestion to adjust the wording of definitions within age groups; advisory oversight title break downs, auditor, and investigative model; and the process for updating policies with Lexipol.
