3. <u>16-0503</u> Interviews for the Planning Commission [Doris Sorum, City Clerk]

At approximately 4:32 p.m., Doris Sorum, City Clerk, provided background information on current vacancies on the Planning Commission. Ms. Sorum stated Anna Petersen and Stephen Wamback are seeking reappointment and

have provided written responses in lieu of attending tonight's interviews. She stated there are three-year terms available for the District No. 4 position, the Environmental Community position and the Architecture, Historic Preservation, and/or Urban Design position. She noted the Committee will be interviewing three applicants, and concluded by reviewing the interview process.

#### 4. <u>16-0504</u>

Land Use Code Annual Amendment to the Comprehensive Plan and Land Use Regulatory Code Update [Stephen Atkinson, Associate Planner, Planning and Development Services]

At approximately 5:03 p.m., Stephen Atkinson, Planning and Development

Services (PDS), provided an overview of the comments and written responses received from the public hearings held on May 4, 2016 and May 18, 2016 relative to the 2016 Annual Amendment to the Comprehensive Plan and Land Use Regulatory Code, including wireless communication facilities. Jana Magoon, PDS, discussed short term rentals. Mr. Atkinson discussed code cleanups, future land use, North 33rd street and North Pearl street, South Alaska street and South 72nd street, and Cheney Stadium, multi-family design standards, pedestrian streets, build-to area, building design, internal access roads, and concluded by discussing next steps.

Discussion ensued throughout regarding correlation between North 33rd street and North Pearl street and Bates Technical College, building design standards, facility improvements, required conditional use permits on short term rentals, public notifications, impacts on accommodating accessory dwelling unit agreements, multi-family units, changes and potential use, commercial zones, pedestrian streets, and additional proposals.

Rebecca Boydston, Committee Liaison, stated the next meeting will be on June 22, 2016, and will include an update on the Unified Development Code.
