#### JOINT MEETING WITH THE PUBLIC UTILITY BOARD

#### Call to Order

Mayor Woodards called the joint study session to order at 12:13 p.m.

**Present:** 9 - Beale, Blocker, Hines, Hunter, McCarthy, Thoms, Ushka, Walker and Mayor Woodards

Public Utility Board Members:

Mayor Woodards provided opening remarks. Public Utility Board (PUB) Chair Larkin introduced the PUB members.

City Manager Elizabeth Pauli invited Tory Green, Chief, Tacoma Fire Department, to provide an update on current actions and future plans regarding the COVID-19 outbreak in Washington State.

Mayor Woodards stated that the State of the City Address will be shifted from an in-person event to a video broadcast in order to minimize public contact.

Discussion ensued regarding health protocols, actions being taken within the City, supplies for service providers, vulnerable populations, jurisdiction and communication, and protocols for prisons and detention centers.

## Joint Council / Public Utility Board Briefing Items

1. <u>20-0188</u> Advanced Electric and Water Meters: Program Update and Customer Benefits

At approximately 12:35 p.m., Andre Pedeferri, Advanced Meter Program Manager, Tacoma Public Utilities (TPU), presented the advanced electric and water meters program update, including advanced meter infrastructure; advanced meters in the Pacific Northwest; program scope, noting

infrastructure and software; program timeline; 12-month look ahead; the utility modernization strategy; customer benefits timeline; budget and rates impact; meter deployment readiness; customer communications; and a draft of the deployment customer communications plan.

Discussion ensued regarding jobs for meter-checking employees, SAP, payment for meter swapping, utility bills, quality control for meter reading, manual shut off of meters, dealing with leaks in water lines, and customer responsibility versus TPU responsibility.

#### 2. 20-0190 Tacoma Public Utilities Director Performance Review Process

At approximately 1:29 p.m., Karen Larkin, Chair, PUB, presented the TPU Director performance review process, including performance evaluation strategies and a flow chart of actions.

The joint study session recessed at 1:34 p.m.

#### 3. <u>20-0189</u> Classification and Compensation Study

At approximately 1:40 p.m., Gary Buchanan, Director, Human Resources (HR), made opening remarks and introduced Kari Louie, Senior Compensation and Benefits Manager, HR. Ms. Louie presented the class and compensation study, including the agenda; background; actions to date; what is happening now, noting new classification structure and compensation structure development; project timeline; and next steps.

Discussion ensued regarding new classifications, classified positions versus unclassified positions, implementation plans, compensation plans, and equity concerns.

The joint study session recessed at 2:03 p.m.
