SUMMARY AND PURPOSE:

A resolution authorizing the acceptance of a donation from a former City of Tacoma Library employee in the amount of \$218,486.04. Per Policy 2.20 Acceptance and Use of Donation, any cash or check or other financial instrument valued at greater than \$200,000 requires City Council acceptance/approval.

BACKGROUND:

This Department's Recommendation is Based On the requirement to have City Council approval per Policy 2.20 Acceptance and Use of Donation, Cash or Check or other financial instrument valued at greater than \$200,000. A former City of Tacoma Library employee named the City as a beneficiary in their life insurance annuity and the City is in receipt of the annuity in the amount of \$218,486.04. Per Policy 2.20 Acceptance and Use of Donations, any cash, check or other financial instrument valued at greater than \$200,000 requires City Council acceptance/approval.
