SUMMARY:

The Finance Department, Purchasing Division recommends a contract be awarded to Barnhart Crane & Rigging d/b/a Sicklesteel Cranes, Mount Vernon, WA in the amount of \$400,000, plus applicable sales tax and a contract to Snell Crane Service, Inc., Olympia, WA in the amount of \$300,000, plus sales tax for medium to heavy-lift crane rental services as needed by departments. The contract term will be for one year with the option to renew for four additional one year terms. The specification documents contain market-based provisions for price escalation/de-escalation that will affect overall contract value. The cumulative total of these contracts for the five year period is \$700,000, plus applicable sales tax. Two contracts are being recommended to allow departments to select the vendor who gives the best service rate for type of equipment needed and to have adequate service location coverage. Primary contract users consist of Tacoma Public Utilities Water, Power and Rail Divisions. General Government departments use less than one percent of the contract.

STRATEGIC POLICY PRIORITY:

• Encourage and promote an efficient and effective government, which is fiscally sustainable and guided by engaged residents.

BACKGROUND:

ISSUE: The current citywide contract expires with no options to renew. These contracts allow for the continuation of crane rental services used by various City departments as needed. These "as-needed" contracts offer various types and sizes of cranes at fixed rates.

ALTERNATIVES: Not awarding these contracts could result in higher service rates, less availability of equipment and for emergency purposes, the possibility of no guaranteed response time to a specific location.

COMPETITIVE SOLICITATION: Request for Proposals Specification No. CT15-0517F was opened October 6, 2015. Fifteen companies were invited to bid in addition to normal advertising of the project. Four submittals were received.
