# COMMENTS AND COMMITTEE REPORTS OF THE CITY COUNCIL

#### **Economic Development Committee**

Council Member Campbell, Chair of the Economic Development Committee, reported on June 13, 2017, the Committee heard an annual update on the Economic Development Framework, an informational briefing on the formation of a biotech incubator in Tacoma, and a presentation on a new vision for the Urban Clean Water Innovation Partnership Zone and Tacoma's first water technology accelerator. He stated on June 27, 2017, staff presented an annual update on the Northwest Seaport Alliance and Port of Tacoma activities, and an update on international development and activities at the World Trade Center. Finally, he reported on July 11, 2017, the Committee was briefed on Neighborhood Business District program activity and industrial activities.

Deputy Mayor Thoms thanked staff for working with Tacoma Public Utilities to save approximately \$70,000 in hooking up utility services for the homeless. He then highlighted curb cleanups and striping in the North End Historical District and thanked the neighbors for their efforts.

Council Member Campbell announced there will be an open house on July 20, 2017 at 5:00 p.m., at Good Hope Community Church, to talk about the repaving of East 64th Street. He then stated the Council passed the fourth package of street improvements last week, including paving around Boze Elementary, and reminded everyone the street packages are discussed at the Council meetings and information can also be found on the City's website. Finally, he thanked Metro Parks for working with the City on the dedication of Reginald Gutierrez Lane.
