### WORK SESSION

The focus of the work session moved from the Library's ten-year and two-year strategic goals to focus on the requirement to decrease the Library's 2016-2017 baseline budget by \$903,000. This requirement was sent to General Government departments and agencies on Wednesday, May 25<sup>th</sup>. The modified budget is to be in the City's budget system by end of Friday, June 10<sup>th</sup>.

After discussing the various options, the Board of Trustees instructed the Director to submit two budgets. One budget would reflect the closing of Kobetich Library. The other would reflect closing the Northwest Room and further cutting the purchase of books, magazines, newspapers, CDs, and DVDs as well as digital materials.

The Board of Trustees intends to meet with City Council members as well as the City Manager.

## **NEW BUSINESS**

RESOLUTION 16035: Request that the Board approves the one day closure of Mottet and South Tacoma branches for the annual Summer Reading Club Zoo Party on Saturday, August 13, 2016.
