1. <u>23-1234</u> Title 6 Amendments - Utility Tax Chapters [Danielle Larson, Tax and License Division Manager, Finance]

At approximately 10:02 a.m., Danielle Larson, Tax and License Division Manager, Finance, presented the Title 6 amendments on Solid Waste tax collection including an overview, background, issues, proposed amendments, a possible tiered tax deduction, outreach, and next steps.

Discussion ensued throughout regarding the proposed Title 6 amendments.

23-1235 Multifamily Property Tax Exemption 2023 Program Review
 [Debbie Bingham, Program Manager, Community and Economic Development]

At approximately 10:20 a.m., Chair Hines began with opening remarks and explained the Multifamily Property Tax Exemption program.

Debbie Bingham, Program Manager, Community and Economic Development, presented the Multifamily Property Tax Exemption 2023 Program review, including Tacoma's program; 2023 highlights, noting tax revenue gained in 2022; included areas; and changes coming, noting proposed residential target areas.

Discussion ensued regarding aging projects becoming more affordable, 70 percent Area Median Income, marketing plan, renters ability to find available affordable housing, 12 year projects, projects for 2024, the upcoming renewal, possibility of moving away from 8 year projects, the need for more housing in Northeast Tacoma, projects converting from 8-year to a 12-year agreement, survey of residents, and the timeline for next steps.
