



## RESOLUTION NO. 40047

1 A RESOLUTION relating to the vacation of City right-of-way; setting Thursday,  
 2 August 23, 2018, at 1:30 p.m., as the date for a hearing before the City of  
 3 Tacoma Hearing Examiner on the petition of Doreen and Christopher Gavin  
 4 to vacate a southerly portion of North 32nd Street, lying between North  
 Cedar and North Junett Streets, to facilitate private improvements and  
 landscaping.

5 WHEREAS Doreen and Christopher Gavin, having received the consent of  
 6 the owners of more than two-thirds of the properties abutting a southerly portion of  
 7 North 32nd Street, lying between North Cedar and North Junett Streets, have  
 8 petitioned for the vacation of the following legally described right-of-way area:

10 A portion of the Northeast Quarter of the Southwest Quarter of Section 30,  
 11 Township 21 North, Range 3 East of the Willamette Meridian being more  
 particularly described as follows:

12 The Southerly 10.00 feet of North 32nd Street abutting Lot 3, Block 55,  
 13 Tacoma Supplementary Map as recorded in Volume 1 of Plats at Page 11,  
 14 Records of Pierce County, State of Washington;

15 Now, Therefore,

16 BE IT RESOLVED BY THE COUNCIL OF THE CITY OF TACOMA:

17 Section 1. That Thursday, August 23, 2018, at 1:30 p.m., is hereby fixed  
 18 as the date and time, and the Council Chambers on the first floor of the  
 19 Tacoma Municipal Building, 747 Market Street, in the City of Tacoma, as the  
 20 place when and where said request will be heard by the Hearing Examiner and  
 21 his recommendations thereafter transmitted to the Council of the City of  
 22 Tacoma.
