REPORTS BY THE CITY MANAGER

City Manager T.C. Broadnax stated that the City of Tacoma has been selected to receive a \$250,000 national grant for the development of a subarea plan for the Tacoma Mall Regional Growth Center. He also announced that the City's new arts television program, ArtTown, won silver and bronze Telly Awards for excellence.

COMMENTS AND COMMITTEE REPORTS OF THE CITY COUNCIL

Economic Development Committee

Council Member Campbell stated since the last report, the Economic Development Committee heard an update on key financial indicators for fourth quarter 2013; received a presentation from the Puget Sound Regional Council on Tacoma's strengths and economic development opportunities for the future; heard presentations from the Tacoma Arts Commission on 2013 accomplishments and plans for 2014; heard a presentation from the Foss Waterway Development Authority on a recap of 2013, and future development opportunities and needs for 2014 and beyond. He stated the Committee also heard about the potential for installing artwork on Tacoma Dome; heard from Simpson Investment Company on the timber industry and new housing

construction, and potential impacts to the Tacoma job market and City revenue; and finally, learned about the Community and Economic Development Department's plans to conduct a review of the Neighborhood Business District program this year. He stated at the Committee's next meeting, they are scheduled to hear about Goodwill job training programs and recommendations on the Small Business Enterprise program.

Council Member Boe reminded everyone that May is Bike Month, and related events can be found at bike253.com. He noted the kick-off for Bike Month is this Saturday, May 3, 2014 with the Tacoma Wheelmen's Club from 10:00 a.m. to 2 p.m. to get bikes, parts, and accessories. He announced that Thursday, May 1, 2014 is the opening day of the Broadway Farmer's Market and Bike to Market Day and the first 50 people who verify that they arrived by bike will get a \$2 token to be spent at the market, and on Friday, those interested can get their bike interdenominationally blessed at the Blessing of the Bikes at Urban Grace Church at 8:00 a.m.

Council Member Boe also noted in honor of both Bike Month and Historic Preservation Month, on Saturday, May 10, 2014, at 10:00 a.m. individuals can join in a Tweed Ride from the Point Defiance Pagoda, along the route of Tacoma's first street car line, down 6th Avenue to downtown. He then stated May is also Historic Preservation Month, and this weekend, those interested can join the Historic Homes Tour of Tacoma's tour of North Tacoma highlights on Saturday and Sunday. Finally, he noted for youth interested in theater, the Tacoma Musical Playhouse has a special production of The Prince and the Pauper on Saturday and Sunday.

Council Member Mello announced the Harvest Pierce County Community Garden Summit at Gray Middle School this weekend from 10:00 a.m. to 2:00 p.m. He noted the event is free and family-friendly with childcare and lunch provided for attendees and those interested can register at harvestpiercecouny.org.

Council Member Lonergan thanked everyone who came out to last weekend's community cleanup, and announced that this weekend's cleanup will take place in the Spooner Tract, Fern Hill, Blueberry Park neighborhood, with collection of unwanted items for disposal at Larchmont Elementary School from 10 a.m. to 2 p.m. this Saturday. He stated the cleanup schedule can be found at: cityoftacoma.org/communitycleanup.

Council Member Ibsen added that the Guadalupe Gala and silent auction is this Saturday at Holy Cross Parish will raise money for Guadalupe House, and celebrate Father Bill "Bix" Bicschel's birthday.
