Briefing Items

1. [24-0678](#) Nuisance Code Review - Tacoma Municipal Code Chapter 8.30
[DeJa Irving, Code Compliance Supervisor, Neighborhood and Community Services]

At approximately 4:33 p.m., DeJa Irving, Code Compliance Supervisor, Neighborhood and Community Services, presented on Tacoma Municipal Code Chapter 8.30 regarding nuisance, including an overview, defining a public nuisance, current code, intent of review and update, stakeholder engagement, and timeline.

Discussion ensued regarding stakeholder engagement, availability of draft code review, final recommendations, creating an inspector handbook, and community engagement.

2. [24-0679](#) Anti-Displacement Strategy Update
[Ted Richardson, Strategic Initiatives Coordinator, Office of Strategy]

At approximately 4:48 p.m., Ted Richardson, Strategic Initiatives Coordinator, Office of Strategy, presented the Affordable Housing Anti-Displacement Strategy update, including an agenda; background; ongoing/existing work; work underway; priority potential future actions; preservation ordinance, noting high-cost investment for purchasing more nonprofit units for a higher impact; and community prioritization, noting more support for residents.

Discussion ensued regarding community prioritization; University of Washington Evans School of Public Policy and Governance report; preservation ordinance; funds available to residents; census tract; and permitting process.

3. [24-0681](#) Rental Housing Code Update
[Ted Richardson, Strategic Initiatives Coordinator, Office of Strategy; ChiQuata Elder, Landlord-Tenant Program Coordinator, Office of Equity and Human Rights]

At approximately 5:11 p.m., Richardson and ChiQuata Elder, Landlord-Tenant Program Coordinator, Office of Equity and Human Rights, together presented the Rental Housing Code update, including background; an overview of the phases of research; phase one, noting income to rent ratio and digital tenant information packet; phase two, noting landlord fairness code study, details, and timeline; and feedback.

Discussion ensued regarding digital tenant packet availability with translation options, qualitative and quantitative data, case management system update, request for further findings on what is causing the burden in the court systems and getting residents back into units they own.

SECONDED BY: Deputy Mayor Hines.


ACTION: Voice vote was taken and carried. The motion was declared adopted.
