# 1. Call to Order; Roll Call

#### **Chair Mattran**

Lisa Jaret provided a budget overview for the 2025-26 program year, along with background information on funding goals, application review process, and the funding opportunity. Vice Chair Kendrick and TCAB member Holly Smith then shared who the other panelists were, discussed the panel process, and presented the panel's funding recommendations.

Chair Mattran called for a motion to "approve the Impact Funding recommendations for the 2025-26 funding cycle."

There was robust conversation between TCAB members. Lots of observations were shared, and questions asked which Vice Chair Kendrick and TCAB member Holly Smith were able to address. Lisa Jaret was also able to provide clarification and context for some questions as well.
