Review of Letters of Interest for "For" and "Against" Committees for Measures on the November 7, 2023, General Election Ballot [Debra Casparian, Deputy City Attorney, City Attorney's Office]

At approximately 10:03 a.m., Debra Casparian, Deputy City Attorney, began speaking in reference to the City Council Meeting on July 11, 2023, and the adopted Resolution No. 41237 and Resolution No. 41238 placing measures No. 1 and No. 2 on the ballot for the November election. She explained the process of how the City Clerk's Office advertised for the names and people that would prepare statements for the voters ballot and deadline for the submittal process. She continued by pointing out differences between the seven letters received and the groups that submitted them.

Discussion ensued regarding clarification on each motion, the process of finding the people for the "For" and "Against" committees, the process in the future.

2. <u>23-0744</u> Class and Compensation Overview and Update [Shelby Fritz, Director, Human Resources]

At approximately 10:32 a.m., Shelby Fritz, Director, Human Resources, provided opening remarks stating that prior to this study that started in 2019, there had been a ten year delay with the prior study being done in 2009. Fritz presented the non-represented employee classifications, including an overview; background; study goals; timeline, noting feedback from employees that the study did not recognize employees who had been with the City for a long period of time compared to new employees; and next steps.

Discussion ensued regarding the last study completed, a systematic way to get this study on a similar cycle as the Charter Review, time frames for reviews, what role the labor union had in the process of the study, and the step levels for each classification.
