

ORDINANCE NO. 29049

AN ORDINANCE relating to sewerage; amending Subchapter 12.08B of the Municipal Code, relating to Use of Sanitary Sewer, by amending Section 12.08B.210, entitled "Rates and fees for wastewater service inside the City limits", to change the assumed water usage for customers with incomplete or no winter flow records.

WHEREAS wastewater rates are a combination of a fixed rate and a variable rate based on water usage during the winter months (December through March) referred to as the Winter Quarter Average ("WQA"), and

WHEREAS customers who do not have flow records during this period or have incomplete records are billed with an assumed flow amount, per the Tacoma Municipal Code ("TMC"), of 6.0 hundred cubic feet ("ccf") per month for single-family dwellings and 5.0 ccf per unit per month for multi-family dwellings, and

WHEREAS staff researched the average WQA flows for residential wastewater customers from the last three years and found the average water usage is lower than current assumptions by 1.0 ccf per month, and

WHEREAS this proposed amendment to the TMC will lower wastewater bills for new residential customers in single- and multi-family dwellings when limited or incomplete water consumption history is available, and

WHEREAS the amendment also updates the assumed flow to better match the average customer's actual usage; Now, Therefore,

BE IT ORDAINED BY THE CITY OF TACOMA:

Section 1. That the City Council hereby adopts the Recitals of this Ordinance as its formal legislative findings.



Section 2. That Subchapter 12.08B of the Municipal Code, relating to
Use of Sanitary Sewer, is hereby amended, as set forth in the attached Exhibit
"A."

Section 3. That the City Clerk, in consultation with the City Attorney, is authorized to make necessary corrections to this ordinance and Exhibit "A," including, but not limited to, the correction of scrivener's/clerical errors, references, ordinance numbering, section/subsection numbers, and any references thereto.
