#### COMMENTS AND COMMITTEE REPORTS OF THE CITY COUNCIL

Infrastructure, Planning, and Sustainability Committee

Deputy Mayor Walker, Chair of the Infrastructure, Planning, and Sustainability Committee, reported at the January 11, 2023, the Committee held elections for Committee Chair and Vice Chair, and received presentations on the McKinley Hill Neighborhood Plan and the Mountain Division rail line divestment. She concluded by stating the next meeting will be held in a hybrid format on January 25, 2023, at 4:30 p.m., and will include presentations on the HIT Project Phase 2, 2023 Annual Amendments to the Comprehensive Plan and Land Use Regulatory Code, and the trees in the right-of-way code.

Council Member Ushka announced the Lunar New Year celebration in the Lincoln District, noting it will be from 10:00 a.m. to noon on Saturday, January 28, 2023; it is the Year of the Rabbit; in awareness of the shooting at a festival in Monterey Park, California, security will be taken seriously; expressed appreciation to City staff for assisting with the security and clean up of the event; and shared a quote from a member of the Commission on Immigrant and Refugee Affairs.

Mayor Woodards provided an update on the behavioral health crisis response team, noting the goal is to have the team ready by the end of June; and shared details about the Business Services Manager position, including that it is now posted online to receive applications, a description of the position, and the salary. She continued by acknowledging the recent shootings involving youth, noting review of the Tacoma Violent Crime Reduction Plan, pulling together all services available to address crime in the community, and expressing appreciation to the City's first responders. Mayor Woodards concluded by announcing there are available positions in the Tacoma Police Department.
