SUBJECT: Request to Set a Public Hearing Date for the 2023-2024 Operating Budget, the 2023-2024

Capital Budget, and the 2023-2028 Capital Facilities Program (CFP)

**DATE:** October 12, 2022

#### **SUMMARY AND PURPOSE:**

Setting November 1, 2022 and November 15, 2022 as the dates for the City of Tacoma's first and second public hearings on the proposed 2023-2024 Biennial Operating Budget and the 2023-2028 Capital Facilities Program & 2023-2024 Capital Budget and directing the City Clerk to prepare and circulate proper notices of the time and place of such hearings.

#### **BACKGROUND:**

This Department's Recommendation is Based On: In accordance with RCW 35.34, the City Manager is required to prepare and submit a preliminary budget and budget message to City Council and the City Clerk, after which the City is required to hold public hearings on the proposed budget prior to City Council making changes and adopting the Budget in its final form. The City is required to hold a public hearing at which any taxpayer may appear and be heard on any part of the budget prior to adoption.

Additionally, each year, proposed amendments to the Comprehensive Plan are considered by the Planning Commission and the City Council. The Growth Management Act, with few exceptions, requires that all proposed Plan amendments be reviewed concurrently and no more frequently than once each year [RCW 36.70A.130 (2) (a)]. This is usually referred to as the "annual amendment" whereby individual Comprehensive Plan amendments are considered together. An exception is the amendment of the Capital Facilities Element of the Comprehensive Plan, which may be adopted separate from other proposed amendments to the Comprehensive Plan if it occurs concurrently with the adoption or amendment of the City's budget [RCW 36.70A.130 (2)(a)(iv)]. Adoption of the 2023-2028 Capital Facilities Program will occur concurrently with adoption of the 2023-2024 Capital Budget.

# **COMMUNITY ENGAGEMENT/ CUSTOMER RESEARCH:**

The Office of Management and Budget has engaged in several public engagement events and processes. The Office of Management and Budget conducted community engagement and outreach in four different ways:

- The 2022 Community Survey conducted via phone
- Online engagement, including the use of the tool Balancing Act during both the summer and fall of 2022
- In-person engagement, including participation in various community events such as farmers markets and festivals
- Virtual Town Hall meetings with Council Members and the public on the 2023-2024 Proposed Budget
