SUMMARY AND PURPOSE:

Tacoma Water is requesting approval of proposed updates to the Water Rate and Financial Policy to include water quality and other minor language edits.

BACKGROUND:

This Department's Recommendation is Based On:

The Water Rate and Financial Policy gives direction to planning decisions and helps ensure that Tacoma Water provides an adequate supply of safe, clean water to all customers efficiently, reliably, and at the lowest possible cost consistent with prudent utility management. This policy was last updated in November 2022.

COMMUNITY ENGAGEMENT/ CUSTOMER RESEARCH:

Community Engagement. In preparation for this request, Tacoma Water sought input from policymakers during PUB study sessions and members of the public during a PUB meeting public comment period.

2025 STRATEGIC PRIORITIES:

Equity and Accessibility: (Mandatory)

Tacoma Water's Water Rate and Financial Policy addresses equity and accessibility through guiding objectives: rates should ensure adequate supply, set as low as responsible, be fair and equitable, based on long-term financial planning and adjusted gradually, and the product of customer involvement.

Livability: *Equity Index Score*: Moderate Opportunity

Increase positive public perception of safety and overall quality of life.

Improve access and proximity by residents to diverse income levels and race/ethnicity to community facilities, services, infrastructure, and employment.
