3. [21-0854](#) Tacoma Anchor Network Update
[Bucoda Warren, Strategic Initiatives Coordinator, Media and Communications Office]

At approximately 10:04 a.m., Bucoda Warren, Strategic Initiatives Coordinator, Media and Communications Office, gave an update on the Tacoma Anchor Institution Network (TAN), including an overview; a description of what anchor institutions and the TAN are; current members; history, noting the launch of TAN, the accomplishments of 2018 through early 2020 meetings, how TAN responded to the COVID-19 pandemic, and the 2021 adoption of an anti-racist approach; strategic framework process; the TAN mission statement; core priorities; core activities; meetings; initial working groups, noting workforce development, procurement landscape, addressing affordable housing and organizational capacity; and next steps.

Discussion ensued regarding recognition for both current and past staff for their work on this project, TAN's potential and value, and the relationships TAN has created.
