



RESOLUTION NO. 39561

1 A RESOLUTION relating to the Biennial Budget; setting November 1 and
2 November 8, 2016, as the dates for public hearing on the City of Tacoma's
3 proposed 2017-2018 Biennial Budget and proposed 2017-2022 Capital
4 Facilities Program and 2017-2018 Capital Budget.

5 WHEREAS RCW 35.34.100 provides that, following the filing of the
6 preliminary budget with the City Clerk, the Clerk shall publish a notice once a week,
7 for two consecutive weeks, stating that the preliminary budget for the ensuing fiscal
8 biennium has been filed with the Clerk; designating the date, time, and place of the
9 legislative budget meeting; and that any taxpayer may appear and be heard for or
10 against the budget, and

11 WHEREAS RCW 35.34.110 provides that a city's legislative body shall meet
12 on or before the first Monday of the month next preceding the beginning of the
13 ensuing fiscal biennium for the purpose of fixing the final budget of the city at the
14 time and place designated in the notice thereof, and

15 WHEREAS, additionally, proposed amendments to the Comprehensive Plan
16 are considered annually by the Planning Commission and City Council, and, with
17 few exceptions, RCW 36.70A.130(2)(a) requires that all proposed Plan amendments
18 be reviewed concurrently and no more frequently than once per year, and

19 WHEREAS state law provides an exception for an amendment to the Capital
20 Facilities Element of the Comprehensive Plan, which may be adopted separately
21 from other amendments to the Comprehensive Plan if adoption occurs concurrently
22 with the adoption or amendment of the City's budget; Now, Therefore,

Section 1. That the budget hearings prescribed pursuant to RCW 35.34.100 and 35.34.110, for the purpose of considering the proposed 2017-2018 Biennial Budget and the proposed 2017-2022 Capital Facilities Program and 2017-2018 Capital Budget, shall commence on Tuesday, November 1, 2016, and Tuesday, November 8, 2016, at approximately 5:30 p.m., or as soon thereafter as the same may be heard, in the City Council Chambers, First Floor, Tacoma Municipal Building, 747 Market Street, Tacoma, Washington.

Section 2. That the public hearings prescribed pursuant to RCW 36.70A.035, for the purpose of considering the proposed 2017-2022 Capital Facilities Program and 2017-2018 Capital Budget, shall commence on Tuesday, November 1, 2016, and Tuesday, November 8, 2016, at approximately 5:30 p.m., or as soon thereafter as the same may be heard, in the City Council Chambers, First Floor, Tacoma Municipal Building, 747 Market Street, Tacoma, Washington.

Section 3. That the City Clerk shall give proper notice of the time and place of said hearings.
