ORDINANCE NO. 29047

2 AN ORDINANCE related to the vacation of City right-of-way; vacating 3 approximately 1.2 feet of the northerly portion on 6th Avenue and approximately 0.2 of a foot of the easterly portion of North Prospect 4 Street, to cure building encroachments; and adopting the Hearing 5 Examiner's Findings, Conclusions, and Recommendations related 6 thereto. 7 WHEREAS all steps and proceedings required by law and by 8 resolution of the City Council to vacate the portion of the right-of-way 9 hereinafter described have been duly taken and performed; Now, Therefore, 10 11 BE IT ORDAINED BY THE CITY OF TACOMA: 12 Section 1.
