Briefing Items

1. 14-0354 Charter Review Committee Final Report

Mayor Strickland announced the first study session topic is the Charter Review Committee Final Report.

Deputy Mayor Woodards arrived here, at 12:07 p.m.

Bill Baarsma, Charter Review Committee Chair, introduced the Committee Members and provided an overview of the Committee's recommendations, noting all recommendations were moved forward. Chair Baarsma, Vice Chair Justin Leighton, and Committee Member Terri Baker, reviewed housekeeping recommendations from staff, the Pierce County Auditor, and the Human Resources Charter Review Subcommittee; and substantive recommendations related to general topics, accountability for Tacoma Public Utilities, the City Manager and City Attorney, and the form of government. Chair Baarsma concluded by reviewing the list of individuals who submitted minority reports. Discussion ensued throughout regarding the recommendations related to gender neutral language, employment eligibility requirements, financial disclosure, Neighborhood Business Districts, effective ordinance dates, a Salary Commission, performance audits, appointment of the Utility Director, Council staff, and term limits.

Mayor Strickland invited the authors of the minority reports to speak. Committee Members Patricia Talton and Mabel Edmonds stated they do not advocate a change of the current form of government. Discussion ensued regarding the form of government, including voter strength, and the Mayor's role if the form of government changed. Discussion ensued regarding the division of women and minorities on the Charter Review Committee. Chair Baarsma provided closing remarks and Mayor Strickland thanked the Committee for their hard work.
