## **RESOLUTION NO. 41286**

A RESOLUTION relating to the Biennial Budget; setting Tuesday, November 21, 1 2023, upon completion of Regular Agenda Items, no earlier than 5:15 p.m., 2 as the date for public hearings by the City Council on the proposed modifications to the 2023-2024 Biennial Budget Mid-Biennium modification, 3 and 2023-2024 Capital Budget modification. 4 WHEREAS RCW 35.34.130 provides that the legislative body of the City 5 will meet no sooner than eight months after the start nor later than the conclusion 6 7 of the first year of the fiscal biennium for the purpose of a mid-biennial review and 8 modification of the biennial budget, and 9 WHEREAS RCW 35.34.130 also provides that a public hearing must be 10 held on the proposed budget modifications, and that copies shall be furnished to 11 the City's legislative authority and to any taxpayer who shall call and request the 12 13 same, and 14 WHEREAS proposed amendments to the Comprehensive Plan are 15 considered annually by the Planning Commission and City Council, and, with few 16 exceptions, RCW 36.70A.130(2)(a) requires that all proposed Plan amendments be 17 reviewed concurrently and no more frequently than once per year, and 18 19 WHEREAS state law provides an exception for an amendment to the Capital 20 Facilities Element of the Comprehensive Plan, which may be adopted separately 21 from other amendments to the Comprehensive Plan if adoption occurs concurrently 22 with the adoption or amendment of the City's budget; Now, Therefore, 23 BE IT RESOLVED BY THE COUNCIL OF THE CITY OF TACOMA: 24 25 Section 1. That a public hearing on the proposed amendments to the City 26 of Tacoma's 2023-2024 Biennial Budget Mid-Biennium modification, shall be held

2	Municipal Building, 747 Market Street, Tacoma, Washington, on Tuesday,
3	November 21, 2023, no earlier than 5:15 p.m.
4	Section 2. That a public hearing prescribed pursuant to RCW 36.70A.035,
5 6	for the purpose of considering proposed amendments to the 2023-2024 Capital
7	Budget modification, shall commence on Tuesday, November 21, 2023, no earlier
8	than 5:15 p.m., in the City Council Chambers, First Floor, Tacoma Municipal

10	Building, 747 Market Street, Tacoma, Washington.
11	Section 3. That the City Clerk shall give proper notice of the time and
12	place of said hearings.
