SUBJECT: Contract for Liquid Polyaluminum Chloride for Wastewater Treatment.

Budgeted from Wastewater Fund 4300

Request for Bids Specification No. ES13-0369F

RECOMMENDATION: Environmental Services, Operations and Maintenance Division recommends a contract be awarded to low bidder Kemira Water Solutions, Inc., Lawrence, KS, for purchase of liquid polyaluminum chloride for the treatment of wastewater. The recommendation is for an initial two-year contract term in the amount of \$229,500.00, sales tax not applicable, plus the option for three additional one-year renewal periods, for a cumulative amount of \$609,337.00, sales tax not applicable. The specification documents contain marketbased provisions for price escalation/de-escalation that will affect overall contract value. The cumulative amount is based on an estimated 5% annual inflation for each renewal option.

EXPLANATION: Liquid polyaluminum chloride is a high performance liquid coagulant used in the treatment of wastewater.

COMPETITIVE SOLICITATION: Request for Bids Specification No. ES13-0369F was opened September 24, 2013. 13 companies were invited to bid in addition to normal advertising of the project. Three submittals were received. The table below reflects the amount of the initial contract term.
