# FIRST READING OF ORDINANCES

#### 15. **ORD28376**

An ordinance adopting the 2016 Annual Amendment to the Comprehensive Plan and Land Use Regulatory Code; and amending various chapters in Titles 1 and 13 of the Municipal Code, to implement said amendments, as recommended by the Planning Commission.

MOTION: Deputy Mayor Mello moved to amend Exhibit "B" of Ordinance No. 28376 at Page 15, TMC 13.06.200.D, Building Envelope Standards, as follows:

- 1) at column "T" of the "Minimum Lot Area row," add the phrase
- "1,500 square feet per residential unit" after the phrase
- "0 non-residential," and delete all content that follows;
- 2) at columns "C-1," "C-2" and "PDB" of the "Minimum Lot Area row," delete all contents except the number "0";
- 3) at the "Maximum Building Coverage" row title box, add the phrase
- "- applies to single-use multi family residential development only";
- 4) at the "Usable Yard Space for residential development" row title box, amend the title to read "Usable Yard Space applies to single-use residential development only"; and
- 5) at the "Tree Canopy Coverage for residential uses (percent of lot)" row title box, amend the title to read "Tree Canopy Coverage (percent of lot) applies to single-use residential development only."

- 1) add a sentence to the end of the content in the heading row that reads "all buildings with rooflines of 100 feet or more in length, except where otherwise noted, must use one or more of the following roofline choices."; and
- 2) at the first row title box, "Roofline Choices", delete the parenthetical that reads "(all buildings shall use one or more of the roofline options)."

13.06.575 Short-term rental.

#### B. Standards.

1. Owner occupancy. For short-term rentals that involve rental of individual guest rooms within a dwelling, the dwelling must be occupied by an owner of record during the rental term.

Whenever practicable, the established grid pattern should be preserved and enhanced to achieve the City's goals for urban form and design and development. And renumbering the remaining paragraphs accordingly.
