Combined Committees, Boards and Commissions Reports
[Landmarks Preservation Committee; Sustainable Tacoma Commission; Transportation
Commission]

At approximately 4:37 p.m., Chair Walker provided background on each committee, board, and commission (CBC). Together, CBC liaisons and leadership presented reports on their respective CBCs, including background, commission, recent work, and upcoming work. Reuben McKnight, Staff Liaison, presented for the Landmarks Preservation Commission (LPC). Evlondo Cooper, Co-Chair, presented for the Sustainable Tacoma Commission (STC). Carrie Wilhelme, Staff Liaison, and Matthew Stevens, Co-Chair, presented for the Transportation Commission (TC).

Discussion ensued regarding the LPC, including property taxes and how they are used, and amounts invested for qualification.

Deputy Mayor Hines arrived here, at 4:50 p.m.

Discussion continued regarding the LPC, including Blue Mouse Theatre, work with the Puyallup Tribe, applications for commercial verses single-family residential home projects, historic inlays from sidewalks and the installation of ADA ramps, and historic districts.

Discussion continued regarding the STC, including appreciation for the one on one meetings held with Council Members and the Commission, and adding a list of small sustainability grants on the City website for public view and to showcase grant funding.

Discussion continued regarding the TC, including the name change of the Transportation Master Plan (TMP), coordination with Home in Tacoma amendments, Equity Index, transit oriented development, Streets Initiative Phase 2, the City's design manual update project, federal guidelines for the manual on uniform traffic control devices, Pacific Avenue Subarea Plan update and timeline, Commissioners joining subarea projects, and Hoboken, New Jersey's Transportation Plan.
