Leadership ICMA Report: Human Services Funding [Pamela Duncan, Neighborhood and Community Services]

Ms. Duncan provided an overview of the Leadership International City/County Management Association (ICMA) report on human services funding, including background information, the process, key findings, recommendations, and implementation.
