**SUMMARY AND PURPOSE:**

A series of 19 ordinances authorizing the ratification and confirmation of 19 ordinances previously adopted by the City Council between November 20, 2023, and December 20, 2023, for the purpose of curing a procedural defect arising from an inadvertent omission in the publication of each ordinance.

**BACKGROUND:**

The City of Tacoma has adopted an official newspaper for the publication of ordinances as required pursuant to RCW 35.22.288. This statute, together with Section 2.13 of the City Charter, require that the City publish the ordinance in the official newspaper within ten days of passage. Between November 20 and December 20, 2023, the City Council adopted 19 ordinances, in addition to a bond refunding ordinance, and timely requests for publication of each ordinance were filed with the City's official newspaper. The City was notified on the afternoon of December 28, 2023, that the requested notices were not published due to an inadvertent omission by the official newspaper. Failure to publish the ordinances as required by statute and the City Charter has created a procedural defect in each ordinance which can be cured by ratification and confirmation of each ordinance by the City Council. The following adopted ordinances are subject to the above-described procedural defect: 28911, 28912, 28913, 28914, 28915, 28916, 28917, 28918, 28919, 28921, 28922, 28923, 28924, 28925, 28926, 28927, 28928, 28929, and 28930. The City Attorney's Office recommends that the City Council approve each of the 19 proposed ordinances to correct the procedural defects in each ordinance. The procedural defect for Ordinance No. 28920 will be cured separately through adoption of a new ordinance, which will repeal Ordinance No. 28920 upon its passage.

**COMMUNITY ENGAGEMENT/ CUSTOMER RESEARCH:**

The Council Action Memorandums filed with each of the 19 previously adopted ordinances to be ratified and reconfirmed describe who will potentially be affected by the proposals set forth in each such ordinance and the community engagement that occurred. No community outreach was conducted for the proposed 19 curative ordinances as there will be no change in the effect of these ordinances.
