

ORDINANCE NO. 28785

AN ORDINANCE relating to pay and compensation; amending Chapter 1.12 of the Tacoma Municipal Code to implement rates of pay and compensation for employees represented by the District Lodge #160, on behalf of Local Lodge #297 of the International Association of Machinists and Aerospace Workers, Track Workers Unit and Rail Mechanics Unit, and to implement changes to reflect the organizational structure; and declaring the effective dates thereof.

BE IT ORDAINED BY THE CITY OF TACOMA:

Section 1. That Section 1.12.115 of the Tacoma Municipal Code is hereby

amended, effective December 6, 2021, to read as follows:

1.12.115 Deferred compensation.

* * *

I. The City will match the deferred compensation contributions of Rail personnel in the classification of Railway Yard Clerk (CSC 7101) as set forth in the collective bargaining agreement between the City of Tacoma and the District Lodge #160, of the International Association of Machinists and Aerospace Workers, Yard Clerk Unit.

J. The City will match the deferred compensation contributions of Rail personnel in classifications as set forth in the collective bargaining agreement between the City of Tacoma and the District Lodge #160 of the International Association of Machinists and Aerospace Workers, Rail Mechanics Unit.

1.12.640 Application of additional rates.

L160 BLM. An employee in a classification represented by the District Lodge #160 on behalf of Local Lodge #297 of the International Association of Machinists and Aerospace Workers, Rail Mechanics Unit, and hired after December 11, 2018 will not be eligible to receive longevity pay.

L160 BLM. An employee working in a classification represented by the District Lodge #160 on behalf of Local Lodge #297 of the International Association of Machinists and Aerospace Workers, Rail Mechanics Unit on the date of Council ratification of the 2021-2023 collective bargaining agreement will receive a one-time, lump sum payment of \$2,000.

L160 BLU. An employee in a classification represented by the District Lodge #160 on behalf of Local Lodge #297 of the International Association of Machinists and Aerospace Workers, Rail Track Workers Unit, and hired after December 11, 2018 will not be eligible to receive longevity pay.

Section 12. That Sections 2 and 5 are effective retroactive to January 1, 2021. That Section 1 is effective December 6, 2021. That Sections 3 and 7 are effective January 1, 2022. That Sections 4 and 8 are effective January 1, 2023. That Section 9 is effective January 1, 2024. That Section 10 is effective January 1, 2025. That Sections 6 and 11 are effective as provided by law. Passed
