5. Colonial Court Limited Partnership Loan Modification (Presenter: Sheree Clark)

Staff recommended the TCRA modify the loan to extend its maturity date to July 1, 2015, retroactive to July 1, 2013, to allow the borrower and a potential buyer of the property to close on the purchase of the property. Staff expects the remaining loan balance of \$46,416.46 will be paid off through the property acquisition.
