Joint City Council/Public Utility Board Briefing Items

1. 19-0888 2019 Legislative Session Recap

At approximately 12:08 p.m., Anita Gallagher, Assistant to the City Manager, introduced Alisa O'Hanlon, Government Relations Coordinator, City Manager's Office (CMO); Clark Mather, Community and Government Relations Manager, Tacoma Public Utilities (TPU); and Marian Dacca, State Relations Manager, TPU; and made opening remarks on the 2019 legislative session recap. Together they presented the 2019 legislative session overview; legislative agenda updates, noting fiscal, neighborhoods, and transportation updates; federal issues; and the upcoming calendar.

Discussion ensued regarding funding needed for current projects and resources for projects.

2. <u>19-0889</u> Safety Initiative Update

At approximately 12:37 p.m., Elizabeth Pauli, City Manager, made opening remarks, and introduced John Lawrence, Power Section Manager, TPU. Mr. Lawrence introduced Cheryl Bidleman, Assistant Human Resources Director, TPU, and Matt Janzow, Management Analyst II, TPU. Together, they presented the Citywide Safety Initiative, including an overview, background, injury rate comparison, cost of injuries, the safety commitment and goal, the citywide safety initiative, an update on key objectives, understanding the current state, a summary of the findings, the future program structure, recruiting for the safety director position, and next steps.

Discussion ensued regarding next steps, feedback from employees, classified employees versus represented employees, injuries among employees in the field, types of injuries incurred in the workplace and things that caused those injuries, numbers for Tacoma versus other cities, policies versus the ability to maintain protocols, the professions with highest risk, and safety issues for private employers versus the City.
