## **Briefing Items**

1. 16-0527 Property Crimes Reduction Task Force Report

At approximately 12:05 p.m., Elizabeth Pauli, City Attorney, provided opening remarks and introduced Priscilla Lisicich and William King, Blue Ribbon Property Crimes Reduction Task Force. Ms. Lisicich and Mr. King provided an overview of the Task Force, including the mission, members, information included in the report, process, property crime data for the City, trends, best practices, recurring themes, feedback received from experts and stakeholders, recommendations, criteria, framework and focus areas, and next steps.

Discussion ensued regarding support for the Task Force, defining a systems based approach, neighborhood business districts, recommendations, what types of crimes are included in the data, increasing police presence, community oriented policing, prioritization, concentration of property crimes, prevention strategies, relationship between commercial and residential property crimes, and state and federal funds available.

Presiding Officer Woodards requested that the report be brought before the Community Vitality and Safety Committee to provide recommendations for prioritization. T.C. Broadnax, City Manager, provided information relative to the process for prioritization of the recommendations, and next steps.

#### 2. 16-0528 Streets Initiatives Dashboard

At approximately 1:08 p.m., Kurtis Kingsolver, Public Works Director, provided brief opening remarks and introduced Reid Bennion, Public Works. Mr. Bennion played a short public service announcement, and provided an overview of the Streets Initiatives Dashboard, including background information, funding, total investment, transparency, how to use the dashboard, and concluded by discussing next steps.

Discussion ensued regarding support for the dashboard and its design, permits, impact of matching funds, transparancy, type of funds shown in the dashboard, coordination with utility work being done, history of funding, identifying current and future projects, outreach, method used to prioritize projects, terminology used on the dashboard, start dates and time estimates.
