At approximately 10:03 a.m., Michael San Soucie, City Treasurer, Finance, presented an informational briefing on the City Treasurer's Office including an overview; payroll; investment portfolio, noting City funds in the portfolio are earning interest while being invested; portfolio safety; portfolio liquidity, noting two-thirds of the portfolio is increasing; debt service; payment card industry compliance; cash management, noting training is required for any employee handling money transactions; and other duties.

Discussion ensued regarding treasury being under the umbrella of finance, payments, banking, human resource portfolio, the retirement system, vesting confirmed at five years, retirees' money management, general obligation debt, and short-term holdings with interest rates.
