### Briefing Items

1. [19-0979](#) Tacoma Creates Update

At approximately 12:09 p.m., Kim Bedier, Director, Tacoma Venues and Events (TVE), introduced Amy McBride, Art Administrator, TVE, and made opening remarks on the Tacoma Creates update, including an overview and background.

Council Member Thoms arrived here, at 12:11 p.m.

Ms. McBride presented the team and background; allocations; community engagement; Tacoma Creates as a catalyst; and the pilot project, noting residents. She introduced Shon Sylvia, Executive Director, Metro Parks, who presented the Whole Child Partnership. Ms. McBride further reviewed the pilot project, noting education and organizations.

Council Member Ibsen arrived here, at 12:28 p.m.

Ms. McBride outlined success criteria, local legislation, eligibility criteria, the advisory board recommendation, and next steps.

Council Member Ushka arrived here, at 12:41 p.m.

Discussion ensued regarding capacity funding for newer organizations, areas of focus for under-privileged neighborhoods such as the South End, families that are close to qualifying for free or reduced lunch, how to get programs into under-privileged neighborhoods, adding someone with non-profit experience to the proposed advisory board, the key performance indicators and metrics success criteria, further breakdown of the funds for 2020, adding a representative of the schools to the advisory board, and equity training for the advisory board members.

2. [19-0980](#) Equity in Contracting and Local Workforce Development (Phase 1 Recommendations)

At approximately 1:00 p.m., Tadd Wille, Deputy City Manager, introduced Clifford Armstrong, Program Manager, Neighborhood and Community Services, and made opening remarks for phase one of the equity in contracting and local workforce developments, including the agenda, desired outcomes, and objectives. Mr. Armstrong presented the recommendations, the Office of Minority and Women Business Enterprise (OMWBE) certifications, MWBE requirements, requirement waivers, condition of award, additional training, the outreach plan, and next steps.

Discussion ensued regarding external outreach and staffing recommendations.

## Other Items of Interest

3. [19-0981](#) Council Consideration Request - Furnishings and Equipment at New Directions Crisis Residential Center for Youth

Council Member Hunter discussed a Council Consideration Request (CCR) regarding \$25,000 for furnishings, fixtures, and equipment at New Directions crisis residential center. She stated that she would bring back the CCR pending more data gathered by staff.

4. [19-0995](#) Council Consideration Request - Naming the 34th Street Bridge as the "Harold Moss Bridge"

Mayor Woodards submitted a CCR for support for a resolution to be brought to the City Council on October 1, 2019 to re-name the 34th Street Bridge spanning State Route 7 between East "B" and East "D" Street as the "Harold Moss Bridge."
