#### **SUMMARY & PURPOSE:**

A resolution to increase the Commission on Immigrant and Refugee Affairs membership from 11 to 13. [Council Member Catherine Ushka]

#### **BACKGROUND:**

#### This Council Member's Recommendation is Based On:

On December 12, 2017, The Tacoma City Council adopted Resolution 39892, a resolution establishing a Commission on Immigrant and Refugee Affairs (CIRA), to be composed of eleven members and an alternate, for the purpose of better engaging immigrant and refugee communities, and to work with community partners and staff to identify and advance positive outcomes related to removing barriers for said communities

On September 23, 2021, CIRA presented their annual report to the Community, Vitality and Safety Council Committee. One item highlighted in the presentation is that CIRA is an active commission with work being done in multiple subcommittees. Currently, some Commissioners serve on more than one subcommittee and it creates capacity limitations for CIRA's work. CIRA requested the Council expand CIRA's membership by two members in order to better distribute the work of the Commission.

## **Equity and Accessibility:**

CIRA was established for the purpose of better engaging Tacoma's immigrant and refugee communities; and to work with community partners, City departments, and within the City's Equity and Empowerment framework to identify and advance positive outcomes for members of refugee and immigrant communities related to access to and participation in Tacoma's economic, cultural and civic life and to employment, economic development, public health, student achievement, citizenship, public safety, criminal justice, civic engagement, language access, and protection of civil rights.

Elected officials, boards, commissions, and volunteer leadership will reflect the diversity of the Tacoma community.

The Commission shall brief the assigned City Council Committee on its Annual Workplan and Annual Report. This practice shall continue.

### **COUNCIL MEMBER RECOMMENDATION:**

Sponsors recommend passing this resolution in order to increase CIRA membership in order to allow them to build needed capacity to complete the Commission's goals.
