COMMENTS AND COMMITTEE REPORTS OF THE CITY COUNCIL

Infrastructure, Planning, and Sustainability Committee

Council Member Mello stated the October 22, 2014 meeting included a presentation on the implementation of the Environmental Sustainability Management System at the Central Wastewater Treatment Plant, and an update on a tree planting program in Washington State Department of Transportation rights-of-way. He then stated the November 12, 2014 meeting included Tacoma Public Utilities' Integrated Resource Plan, sustainability measurements, and interviews for the Planning Commission. Council Member Mello noted on December 10, 2014, the Committee was briefed on the City's review of mixed-use centers, and a project with the Department of Ecology to develop a regional approach to storm water management. He then thanked the Committee and staff for their work in 2014. Council Member Mello concluded by stating the Committee's next meeting is scheduled for January 14, 2015, at 4:00 p.m. in Conference Room 16 of the Tacoma Municipal Building North, and will include an update on the Water Ditch Trail, and land use regulations in the 2015 Comprehensive Plan.
