[ORD28678](#) An ordinance amending Chapter 11.05 of the Municipal Code, relating to the Model Traffic Ordinance, Chapter 11.06, relating to Motorized Scooters and Electric Personal Assistive Mobility Devices, and Chapter 11.30, relating to Bicycle, Skateboard, Roller Skates, and Scooter Helmets, to update and clarify rules related to active transportation, including micromobility.

ACTION: Ordinance No. 28678 was set over for final reading next week.

UNFINISHED BUSINESS

There was no unfinished business.

REPORTS BY THE CITY MANAGER

City Manager Elizabeth Pauli provided an update on COVID-19 response efforts, including 99 payments have been made by the Rental Assistance Program totaling over \$92,000; 369 rental assistance applications need additional information before they can continue being processed; the Rental Assistance Fund has received 10 donations totaling \$2,500; the Tacoma Rescue Mission's expanded Emergency Shelter had a soft opening on June 25, 2020, which has begun housing five women with the capacity of housing 50 individuals; \$1.6 million in Coronavirus Aid, Relief, and Economic Security Act funding has been identified to assist with food insecurities, with \$800,000 being allocated to each the Emergency Food Network and Tacoma Public Schools; and the senior meals program served 343 meals in the last week through the Lighthouse and Beacon Activity Centers and by delivery from the City of Tacoma parking enforcement. City Manager Pauli concluded by announcing the launch of a new information site and resource for getting information regarding in custody and deadly force cases involving the Tacoma Police Department.

COMMENTS AND COMMITTEE REPORTS OF THE CITY COUNCIL

There were no Standing Committee reports given.

Council Member Thoms congratulated Governor Inslee on the statewide mask requirement and further thanked Council Member Hunter for making and giving away masks to the community and his family.

Mayor Woodards reminded everyone that the City's official Fourth of July celebration has been cancelled this year and that personal fireworks are illegal within the City limits.

Council Member Hunter reiterated that fireworks are not allowed within City limits; stating they are bad for the environment, birds, dogs, and people with Post-Traumatic Stress Disorder; and encouraged individuals to start new traditions that are safe, healthy, and compassionate.

Mayor Woodards further announced that Pride Month in Tacoma begins Wednesday, July 1, 2020, a proclamation officially declaring July as Pride Month will be brought forward at the Tuesday, July 7, 2020 City Council meeting, and to visit Tacomapride.org to see all of the ways to get involved. She concluded by stating the Pride Flag will be raised over the Tacoma Municipal Building, Tacoma Dome, and Tacoma Public Utilities building; and in recognition of the historic role of the leadership of black

transgender women have played in the lesbian, gay, bisexual, transgender, and queer + (LGBTQ+) movement, the intersectional experiences of the black and brown members of the LGBTQ+ community, and increasing conversations around systemic racism, this year's Tacoma Pride celebrations will feature an intersectional update with the flying of the Philadelphia Pride flag, whose rainbow features additional black and brown strips.
