- Community Participation in plan development is guided by the City's Participation Plan
- Annual component of the City's 2020-2024 Consolidated Plan that sets goals and performance indicators to address housing, homeless, and community development needs
- Outlines the spending plan for 2024 formula allocations:
 - Community Development Block Grants (CDBG): \$2,393,848
 - Emergency Solutions Grants (ESG): \$209,987
 - HOME Investment Partnerships Program (HOME): \$1,458,355
- Programs serve individuals, households, and business owners who earn 80% or less than Pierce County Area Median Income
- Sub recipient agreements between the City of Tacoma, Tacoma Community Redevelopment Authority (TCRA), City of Lakewood & individual contractors.
