Location Updates

Shiloh Standdown

- Shelter completed standdown on March 31st, 2025
- Housing project currently leasing and provides housing services as needed for people who are at or below 60% AMI
- Site provided 40 beds for single adult men
- Site served 317 people since September 2021

Altheimer Standdown

- Standdown schedule on June 30th, 2025
- 32 beds for families
- Site has served 244 people since February 2020

Forging Path Community

- Standdown without funding is June 30th, 2025
- Housing project projected to start in Fall of 2025 and expected to have 81 affordable units at 30-60% AMI
- 135 beds for adults
- Site has served 290 people since November 2022

Freedom Project- Brotherhood Rise

- Lease for location ends June 30th, 2025
- 16 micro-shelter units for adults
- Site has served 48 people since June 2023

- Tacoma requested \$12 million to continue operation of 307 shelter beds.
- An annual allocation of \$58.8 million from the Legislature is designated for statewide grants supporting homeless
 housing programs and services in cities and counties. Although Tacoma isn't explicitly named in the proviso,
 legislative staff have verified the City's eligibility to seek these funds.
- The City will be seeking these funds. However, given uncertainties around the final award decisions and distribution process, the City must develop contingency plans in case this funding doesn't materialize.


TMC 8.19 Implementation

Current Prohibited Areas

The heatmap indicates the 3,300 calls related to homelessness throughout the City of Tacoma over the last quarter.

Yellow boundaries represent areas surrounding temporary and emergency shelter locations which create TMC 8.19 boundaries.

This also includes one temporary shelter location that are not City funded or implemented.
