Rental Housing Code Update

[ChiQuata Elder, Landlord-Tenant/Crime Free Housing Coordinator, Office of Equity and Human Rights; Matthew Jorgensen, Program Development Specialist, Neighborhood and Community Services]

At approximately 5:26 p.m., ChiQuata Elder, Landlord Tenant/Crime Free Housing Coordinator, Office of Equity and Human Rights, introduced Matthew Jorgensen, Program Development Specialist, and Erica Azcueta, Homelessness and Household Stability Program Manager, Neighborhood and Community Services (NCS). Ms. Elder provided an update on the Tacoma Municipal Code Chapter 1.95 relating to the Rental Housing Code (RHC), including background, timeline and process of implementation, number of people served, impacts, enforcement and ensuring habitability, lessons learned, and next steps. Ms. Azcueta reviewed background regarding tenant relocation assistance. Mr. Jorgensen concluded by providing a brief overview of the Tenant Relocation Assistance Program and program updates.

Discussion ensued throughout regarding Code accessibility for people with disabilities, utility and garbage service policies, business licenses, the rollover of funds, the number of languages available for the Tenant Relocation Information Packets, RHC website update, transitional and temporary housing, and clean and sober housing.

Council Member Thoms expressed interest on bringing the safe and clean initiative discussion to the Community Vitality and Safety Committee.

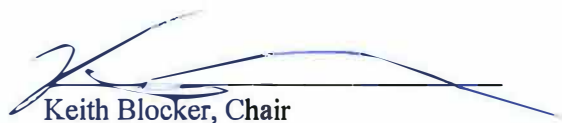

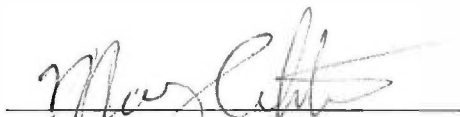
There was no Public Comment.
