SUMMARY AND PURPOSE:

The Legal and Finance Departments of the City of Tacoma seek a resolution authorizing appropriate city officials to execute an agreement with Pierce County for jail services for a period of five (5) years in an amount not to exceed \$9,600,000

BACKGROUND:

The City Council on June 16, 2015, pursuant to Resolution No. 39216, authorized the execution of an agreement with Pierce County to provide jail services for the City of Tacoma effective July 1, 2015, through December 31, 2020. On March 12, 2020, the Pierce County Sheriff's Department Corrections Bureau, in response to confirmed cases of Coronavirus in Pierce County and the potential impact of the virus upon the inmate populations, implemented new booking policies limiting bookings of misdemeanor offenders in an effort to reduce the risk of transmission of COVID-19.

The impacts of the pandemic upon misdemeanor bookings have made it difficult to develop data that will inform discussions of a new jail services contract. As a result, Pierce County requested that the City agree to extend the current jail services contract upon the same terms and conditions for a period of one-year through December 31, 2021. In January 2022, for the same reasons, the City and Pierce County agreed to a one-year extension from January 2022, through December 31, 2022.

In January of 2023, the City Manager authorized a six (6) month extension of Jail Services contract to allow the City and County additional time to develop a new Jail Services Contract. The proposed five (5) year contract from July 1, 2023, through December 31, 2028, is needed for the City to book and house misdemeanor offenders for violations of the Tacoma Municipal Code.

COMMUNITY ENGAGEMENT/ CUSTOMER RESEARCH:

If the Jail Services Contract is not approved prior to its expiration on July 1, 2023, the City will not have a jail service agreement in place in Pierce County to book or sentence misdemeanor offenders.
