Dear Chairs Liias and Fey and Ranking Members King and Barkis:

As members of business, labor, maritime, and local government community, we are writing to express our continued support for the on-time completion of the Puget Sound Gateway.

The completion of the Puget Sound Gateway—composed of state routes 167 in Pierce County and 509 in King County—has been a priority for King and Pierce County citizens for decades and was the keystone to the *Connecting Washington* and an essential element in the *Move Ahead WA* package. It is an essential mobility project that finishes a key component of the region's highway network. It is a critical last mile freight connector for Washington goods grown and manufactured across the state seeking access to foreign markets through the ports of Tacoma and Seattle. And it offers important safety improvements relative to surface streets that must be utilized by heavy vehicles today.

We recognize that the state transportation budget continues to face pressures. Budget writers may need to make difficult choices. With that said, we would urge lawmakers to make budget decisions that ensure the Gateway project remains in scope and on schedule. We believe that any disruptions in the continuity of construction creates additional logistical problems to complete the project by 2029 and would unquestionably result in cost escalation. Moreover, WSDOT staff working on the project would likely be reassigned, resulting in a loss of institutional knowledge. And finally, permits and environmental review may age out and need to be renewed further driving up the costs. Delays could also violate terms of agreements with other Project funding partners.

We deeply appreciate the Legislature's commitment to this project as evidenced by the completion of Phase 1A, the funding provided for Phase 1B (currently under construction) and the funding provides for Phase 2 (currently under procurement). We look forward to partnering with you to ensure all aspects of this corridor of statewide significance is finished as currently budgeted.
