Briefing Items

5. 14-1328 Youth and Young Adult Crisis Center and Emergency Shelter [Pamela Duncan, Neighborhood and Community Serivices]

At approximately 4:36 p.m., Diane Powers, Office of Equity and Human Rights Director, provided background information on the collaboration between the City and Pierce County to address a gap in the service continuum for youth experiencing homelessness, and the establishment of an emergency shelter and crisis support services for youth and young adults. LaMont Green, Pierce County, reviewed youth and young adult homelessness, including current needs, local study results, service gaps, living situations, gang involvement, service groups, and housing initiatives.

Shelley Kiemele Koeppen, Neighbor and Community Services, reviewed the crisis center and emergency shelter project, including phase one and two service levels, partnerships, accomplishments, projected investments, and next steps and timeline. Discussion ensued regarding family structures, the mental health sales tax percentage, funding requirements and sources, site requirements, locations, and youth activities. Chair Woodards requested information on the homeless youth population in the City versus in Pierce County, and funding match requirements.

6. 14-1329 2014 Year End Committee Report and 2015 Committee Work Plan [Genesis Gavino, City Manager's Office]

At approximately 5:10 p.m., Genesis Gavino, City Manager's Office, reviewed the Committee's 2014 End of Year Report. Discussion ensued regarding final reports from the Police and Fire Departments, and the 2015 work plan, including the Committees, Boards, and Commissions process, and renaming the Citizen Review Panel.
