1 BY REQUEST OF DEPUTY MAYOR IBSEN AND COUNCIL MEMBERS BLOCKER,  
2 HUNTER, AND MELLO

3 A RESOLUTION appointing individuals to committees that will prepare statements  
4 "For" and "Against" Proposition No. 1, concerning Tacoma Creates, to  
5 support arts, culture, science, and heritage programs, which will appear in  
6 the voters' pamphlet for the General Election to be held November 6, 2018.

7 WHEREAS, on June 26, 2018, the City Council approved Resolution  
8 No. 40046, transmitting a ballot measure concerning Tacoma Creates, to support  
9 arts, culture, science, and heritage programs, to the Pierce County Auditor to be  
10 placed on the ballot for the General Election on Tuesday, November 6, 2018, and

11 WHEREAS, pursuant to RCW 29A.32.280, for each measure included in a  
12 local voters' pamphlet from a unit of local government, the legislative authority of  
13 that jurisdiction shall, not later than 45 days before publication of the pamphlet,  
14 formally appoint a committee to prepare arguments advocating voters' approval of  
15 the measure and shall formally appoint a committee to prepare arguments  
16 advocating voters' rejection of the measure, and

18 WHEREAS, at its meeting of July 17, 2018, the Government Performance  
19 and Finance Committee reviewed applications and made recommendations for the  
20 appointment of individuals to the "For" and "Against" committees for Proposition  
21 No. 1, and

23 WHEREAS, at a special meeting held on July 19, 2018, the Government  
24 Performance and Finance Committee reviewed applications and made  
25 recommendations for the appointment of additional individuals to the "Against"  
26 committee for Proposition No. 1; Now, Therefore,
