SUBJECT: Resolution - Appointing "For" and "Against" committees for Measures No. 1 and No. 2

concerning Landlord Fairness Code, and Rental Housing Code amendments in TMC 1.95, respectively, being submitted to the voters at the General Election on November 7, 2023.

SUMMARY AND PURPOSE:

A resolution appointing individuals to committees that will prepare statements "for" and "against" Measure Nos. 1 and No. 2 concerning the Landlord Fairness Code, and Rental Housing Code amendments in TMC 1.95, respectively, which will appear in the voters' pamphlet for the November 7, 2023, General Election.

BACKGROUND:

This resolution request is based on the statutory requirement that the City appoint members to a "for" and "against" committee when it seeks to place a measure on the ballot. There are two measures on the ballot in November, the citizen's Landlord Fairness Code submitted by Tacoma for All, and the City's Rental Housing Code amendments in TMC 1.95. These are being sent to the voters on the November 7, 2023, ballot, via Resolution Nos. 41237 and 41238, respectively. Each initiative is required to have "For" and "Against" committee members.

The Government Performance and Finance Committee reviewed letters of interest for these committees at their regularly scheduled meeting on Tuesday, July 18, 2023, and provided recommendations. This resolution would formalize those appointments.

Per RCW 29A.32.280, for each measure from a unit of local government that is included in a local Voters' Pamphlet, the legislative authority of that jurisdiction shall formally appoint a committee to prepare arguments advocating voters' approval of the measure and shall formally appoint a committee to prepare arguments advocating voters' rejection of the measure.

COMMUNITY ENGAGEMENT/ CUSTOMER RESEARCH:

The City reached out to the community to look for those interested in serving on the "For" and "Against committees. The City notified anyone who expressed interest in the past about the topic, and notified those on the agenda notification lists, the contacts for the Neighborhood Councils, and posted the request on the City's notices page.

2025 STRATEGIC PRIORITIES:

Equity and Accessibility: (Mandatory)

Appointing a "For" and "Against" committee is required by state law. It will allow formal support and opposition to both Measures No. 1 and 2, the Citizens' Landlord Fairness Initiative, and the City's Rental Housing Code amendments, respectively.
